ROTC/JROTC

SEA CADET

Philip Hinshaw presented a San Diego Chapter Sea Cadet award for the Outstanding Sea Cadet of the Year and a \$250.00 check last Sunday to a Sea Cadet from the Fort Fisher Division, a junior at the Chula Vista High School. The cadet also submitted paperwork for the Outstanding Sea Cadet of the Year at the state level, CASSAR, and Philip forwarded it to the CASSAR. The Sea Cadet is planning on attending the Naval Academy.

Philip will follow up with the eight Sea Cadet Units in San Diego County and offer to present medals and lapel pins to them.

New Business

Duncan Campbell proposed the Chapter spend approximately \$175.00 to purchase a flagpole, topper, and a gold fringe plus the cost of installing the fringe for the new semi quincentennial flag to keep the flag's appearance the same as all the other flags in the Chapter's inventory.

Bill Weedman motioned the same as above and Fred Hall seconded the motion. President Key called for discussion and none was offered. President Key called for a show of hands to signify an aye vote. The vote was unanimous to proceed.

Duncan discussed plans for the Chapter's upcoming Memorial Day event that will involve national exposure for San Diego and California, but he is having trouble finding a suitable venue to stage the event. Fort Rosecrans will not allow any events until at least the middle of the summer. Duncan tried contacting the Midway but has not received any return communication yet.

Another possible venue might be Liberty Station in San Diego.

Duncan would like to invite Chapters from Arizona and Nevada to join in the Memorial Day event.

Another issue is the Chapter's Zoom license is limited to 100 slots and the state of California has the same limit.

Duncan sent an email to an SAR event coordinator in North Carolina who has a 500 person Zoom limit license asking them to share their license for this event.

President Key will check into up grading the Chapter's license to a 500-person limit for a one-off event.
