## 1st Vice President (Barry Key)

1<sup>st</sup> Vice President Barry Key reported satisfaction with the Chapter presentation given by him and his six fellow officers at the annual Fall Board of Management meeting held at the Wyndham Irvine Hotel in Irvine. Participating Officers were 1<sup>st</sup> Vice President Barry Key, Past President and Registrar Ray Raser, Color Guard Commander Ernie McCullough, Chaplain Stan De Long and Philip Hinshaw. Issues discussed were Color Guard events attended by the Chapter





Color Guard, Wreaths Across America participation and the Middle School Poster Contest amongst other items. By the way, it is now official that all members of the Color Guard that want to fire a musket need to take black powder training from the NRA. It was pointed out during the meeting that Color Guard units from other Chapters, principally Riverside are often paid a fee to participate in events, sometimes as high as \$400.00 depending on the size of the event.

Barry is currently lining up speakers for next year's meetings. He stated he wants speakers who will primarily focus on the Revolutionary War period. Ernie suggested he try and get in touch with Frank Kettlemen who has given several talks on the logistical problems of the Revolutionary War. The San Diego Ladies Auxiliary hosted the Hospitality Suit for this year's meeting. Gail Raser, Maryann McCullough, Mary Hinshaw and Joan De Long manned the suit. Ray Raser was recognized for being the number one registrar in the state. Ray also received the Quilt of Valor for his duty in the Marine Corps.

# (1.) Budget

A motion to approve the budget for 2018 was made by Dick Leslie and seconded by Ed Torrence. Bill Weedman called for a discussion as to who exactly had the right to approve the budget, the Board or the membership. It was decided that approving the budget is a function of the board. Also, because of a different procedure for processing application item 2.1 of the budget was adjusted down \$400.00. Items 5.1.2, Bronze Good Citizenship and Ribbons, was adjusted to \$60.00 and item 5.1.3, Outstanding Cadet Certificate, was adjusted to \$60.00.

Ray Raser led a discussion of how to pay the standard Chapter processing rate of \$35.00 per application. The State Registrar now is responsible for entering the data into the digital application so consequently the money will flow to them from now on. The State Registrar has contracted with a private entity to do the data entry for \$25.00 per application which according to Ray is a bargain. Ray will forward the \$25.00 to the registrar when submitting an application and keep the remaining \$10.00 in the Chapter bank account. In keeping with this new procedure, the following motion was made by Ray Raser:

Allow the treasurer to pay Owen Stiles (person doing the entry) per invoice submitted as Treasurer may deem appropriate for processing new applications on-line data entry. Ed Torrence seconded. No further discussion was called for and the motion passed unanimously by the Board.





Ed Torrence motioned that the budget be passed as amended and Bill Weedman seconded. The Board voted unanimously to accept the budget for 2018.

2018 would be their last year of service. The Chapter is currently looking for a new Treasurer, 1<sup>st</sup> Vice President and 2nd Vice President. The lobbying for new recruits will be undertaken at the Barbecue hosted at Gail and Ray Raser's home on the 9<sup>th</sup> of December.
