It is still up in the air as to whether the Chapter Color Guard will be participating in the Memorial Day ceremony at Fort Rosecrans.

There was a discussion about the difficulty of enlisting new members into the Color Guard due to the high expense of uniforms. Some younger members have expressed an interest in joining the Color Guard but are being impeded by the cost of the uniforms. The

President Key reported on the 143rd CASSAR Spring Meeting of the Membership, held in Concord, CA at the Concord Hilton Hotel. He sketched out the reports for the various Chapter Reports and State Committee reports. He talked briefly about Black Powder Safety and Insurance and problems with AB-424 as it pertains to the SAR and possible work arounds.

A plea for monetary support for the SAR Revolutionary War Museum located in Louisville, KY was made by Chancellor John Dodd of the Orange County Chapter of the SAR.

Reminded members that anyone interacting with youth need to retake the Boy Scout Youth training.

The DAR has set up a rewards program for its members to encourage them to refer new candidates for membership in the SAR.

A San Diego proposed amendment to allow a change of representative at a CASSAR meeting was voted down on grounds of incorrect verbiage. A rewrite and resubmittal for 2019 will be necessary for the amendment to be considered again.

A memorial service was held for members who passed since the last annual meeting in 2018. Robert Moore and John Cahoon from the San Diego Chapter were memorialized.

The San Diego Chapter won two Best Chapter Awards from a total of 40 awards given.

Need to prepare for the Coronado 4th of July parade, actively looking for a convertible to use. Dave Shaffer has a 36 Ford with a rumble seat he would be willing to drive in the parade.

Suggested that members of the fife and drum corps be awarded a figurine commemorating their participation in the parades.





Poster awards will be handed out the first week of June. The middle Schools have requested a Color Guard representative be present at the award ceremony. President Key and Color Guard Commander will attend and make the awards.

Barry along with Philip Hinshaw and Ed Torrence attended the Battle of San Diego Bay celebration on Naval Base Point Loma.
