#### **New Business:**

Chapter Endowment Fund – Hirman. Discussion about the viability of having an endowment fund for a non-profit organization. Jim reports that there is nothing in the rules that prohibit us from having one, and our Chapter has had one previously.

- Jim suggests having a focus for the fund, such as the Youth Programs.
- Table the discussion to develop a proposal for the January meeting.

Update on Wreaths Across America – Christine talked with Jim about the program Looking for someone to go out to get pledges in person. Jim suggests we divide the work among the membership. It is a huge piece of funding for our Chapter and should be a priorty for the Chapter.
